The final examination shall be conducted in accordance with the norms as prescribed by the Council from time to time.
- 4. The shortcoming(s) as mentioned on the reverse page of this Certificate of Approval must be removed within 03 months under intimation to the Council failing which approval shall stand cancelled.
- 5. No admissions shall be taken to the course without prior approval of RCI. In case of violation, RCI will not issue CRR number to the passed out and approval of the course(s) for future may not be considered in future.
